Subject: Regarding obtaining recognition of your school under the provisions of the **Right to Education** to Free and Compulsory Education Act, 2009 (Section 18) and Punjab Right of Children to Free and Compulsory Education Rules, 2011 (Rule 11)

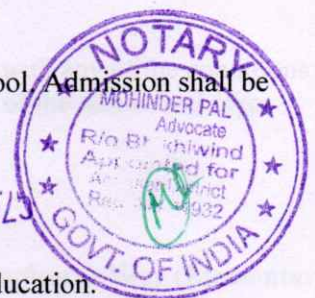
Sir/Madam,

With reference to the subject cited above, you are hereby issued the Permanent Recognition as per the provisions of the **Right to Education** to Free and Compulsory Education Act, 2009 (Section 18) and Punjab **Right to Education** to Free and Compulsory Education Rules, 2011 (Rule 11), every private unaided school is required to obtain recognition from the competent authority.

Therefore, recognition of your school — Millennium World School, Patti, Village Kairon, Block Naushehra Pannuan, District Tarn Taran is issued as per the provisions.

The following instructions must be noted and complied with:

1. The school shall not be run without obtaining recognition; otherwise, it shall be considered a violation of the RTE Act, 2009 and necessary action shall be taken.
2. Recognition will be granted only after ensuring compliance with all the provisions of the RTE Act, 2009 and Punjab RTE Rules, 2011.
3. In case of any violation of the conditions of recognition, 25% of the school's seats in Class I (or the entry-level class) shall be reserved for children belonging to economically weaker sections and disadvantaged groups, and free education shall be provided to them as per the Act.
4. The school building should meet all the safety standards (including safety certificate, fire safety, etc.) prescribed under Rule 12(2) of the Punjab RTE Rules, 2011.
5. No donation or capitation fees shall be charged from students for admission.
6. No screening procedure of any kind shall be adopted while admitting children to the school. Admission shall be made strictly as per the provisions of Section 15 of the RTE Act, 2009.
7. The school shall ensure compliance with the following additional provisions:
 - A. No corporal punishment shall be given to students.
 - B. No child shall be expelled or failed in any class till the completion of elementary education.
 - C. The school shall not collect donations or capitation fees for admission; violation will lead to withdrawal of recognition.
 - D. The management of the school shall ensure compliance with all directions issued by the Department of School Education from time to time.
 - E. For recognition, the school must submit all required documents as per Section 23(1) of the RTE Act to the concerned District Education Officer (Elementary).
 - F. The school must fulfill the responsibilities outlined under Section 24(1) of the Teachers Act.
 - G. Teachers must not keep themselves busy with private tuitions.

7. The school shall not indulge in any commercial activity or profit-making. Any income generated shall be used only for the welfare and development of the school.
8. The school must follow the calendar and curriculum prescribed by the competent authority under Rule 19 of the Punjab Right to Education Rules, 2011.
9. The school premises or any part thereof shall not be used for any non-educational purpose or for the running of any other institution.
10. The school is not being run for the benefit of any individual, group or groups of individuals or any other person.
11. The school must be registered under the **Societies Registration Act, 1860 (Act No. 21 of 1860)** or under the **Trust Act**, and a copy of the registration certificate must be submitted along with the application for recognition.
12. The school management must ensure that qualified teachers possessing the prescribed professional qualifications, such as B.Ed., D.El.Ed., or equivalent, are appointed in accordance with the norms of the National Council for Teacher Education (NCTE). The management shall ensure that no untrained or unqualified teacher is employed in the school.
13. The school management shall not deny admission or expel any student on the basis of caste, religion, gender, or disability.
14. The school shall ensure that records related to students' attendance, admission, and progress are properly maintained and made available for inspection by the competent authority (District Education Officer, Elementary) when required.
15. Ensure that the organization's registration or renewal is done, if necessary.
16. The school must also comply with the directions issued under letter number **R.T.E Tarn Taran – 23080458**, and must take necessary action within the specified time period.
17. The school building must be in safe and good condition. Proper arrangements must be made for clean drinking water, toilets, playgrounds, boundary walls, and other essential facilities. The school must also ensure a clean and hygienic environment within the premises.
18. The school must comply with the provisions of **The Punjab Regulation of Fee of Unaided Educational Institutions Act, 2016 (Punjab Act No. 47 of 2016)**.
19. Under the provisions of the **Right to Education Act, 2009**, if the school fails to comply with any of the conditions mentioned above, the competent authority reserves the right to withdraw the recognition of the school and take appropriate legal action.
